

The Lithium Battery according to PACKING INSTRUCTION 962, 971 and belongs to Class 9 of dangerous goods of the 2021 IATA Dangerous Goods regulations 62nd Edition may be transported. and applicable U.S. DOT regulations for the safe transport of Lithium-ion Battery.

Lithium Battery was protected so as to prevent short circuits. This includes protection against contact with conductive materials within the same packaging that could lead to short circuit;
